CALL TO ORDER

The meeting of the Blockchain & Crypto Mining Association was called to order by President Eli Rouimi.

MOTION

A motion was made by Oleg Flaksman that all BCMA meetings take attendance, meeting notes, and keep a financial spreadsheet of what was spent and that these records be distributed to the officers by email within 5 days of the meeting and was seconded by Sean Markert.

PASSED

MOTION

A motion was made by Oleg Flaksman that BCMA will open a bank account at International Band of Commerce (IBC); that Matt Tunney be approved to open this account and that all officers be added to the account and Treasurer Sean Markert be added as a signer on the account and was seconded by JP La Torre.

Eli Rouimi made a friendly amendment that there be a minimum of three signatures by members of the board for a release of money above one-thousand dollars (\$1,000) and this amendment was approved by Oleg Flaksman.

PASSED

MOTION

A motion was made by Oleg Flaksman that Treasurer Sean Markert opens a Bitgo account to accept cryptocurrency donations at this time, that this account will be viewable only by the officers, and that this account will be used while a committee investigates other methods to accept cryptocurrency donations including Bitpay and CoinPayments, and this motion was seconded by Troy Houtman.

PASSED

COMMITTEES

Eli Rouimi appoints Sean Markert as the head of the crypto finance committee.

All officers are volunteered for this committee including JP La Torre and Devin Blitzer.

MOTION

A motion was made by Sean Markert to incorporate the Join Us documents distributed prior to the board meeting to be the official sign-up sheet for BCMA, and for BCMA to start accepting members. This motion was seconded by Oleg Flaksman.

PASSED

MOTION

A motion was made by Sean Markert to create a minimum miner requirement for all members with voting powers to be verified during the application process and that this minimum be set to 10 miners, whether they are ASIC or GPU miners. This motion was seconded by Troy Houtman.

PASSED

MOTION

A motion was made by Oleg Flaksman that we incorporate the logo identified in the documents distributed prior to the meeting as “Logo 5” as the BCMA logo. This motion was seconded by Eli Rouimi.
